



ISEEU PARIFICATO

The **ISEEU Parificato** is the instrument used by foreign students and Italian students residing abroad to obtain university benefits.

Below are the data and documents required for the preparation of the ISEEU PARIFICATO:

1. IDENTIFICATION DOCUMENTS

- Copy of a valid identity document (passport, identity card);
- Copy of the Italian Tax Code (Codice Fiscale) issued by the Italian Revenue Agency;
- Certificate of residence.

2. FAMILY COMPOSITION

- Certificate of original and current family status as of the date of submission of the Equivalent ISEEU;
- Certificate of residence as of the date of submission of the Equivalent ISEEU.

3. INCOME

- 2025 income tax return for each member of the household, clearly certifying income referring to the **2024** calendar year (*If an adult household member did not earn any income in 2024, a document certifying this is required*)
- CU (Single Certification) issued in 2025 and referring to 2024 income, if you received university scholarships in Italy.

4. REAL ESTATE ASSETS

- Official document certifying ownership of any real estate held by household members as of **31/12/2024**, indicating the square meters and ownership share;

- If there is no real estate ownership, a certificate attesting the absence of property for each adult household member;
- If the household's residence is rented, a copy of the rental contract.

5. MOVABLE ASSETS

- Official documents certifying the household's movable assets as of **31/12/2024**, such as:
 - - Balances of bank and/or deposit accounts;
 - - Balances of share accounts, dividends, equity holdings, capitalization policies, and other financial investments.

6. BUSINESS ACTIVITIES

- Balance sheet as of 31/12/2024 for sole proprietorships or business activities.

7. ADDITIONAL DOCUMENTS

- I.S.E.E. 2026 form (if resident in Italy) for income and assets held in Italy as of **31/12/2024**;
- Any scholarships received, including non-taxable ones, in the two calendar years preceding enrollment.

- Faculty or chosen degree program;
- Student ID number.

N.B. ALL DOCUMENTS MUST BE TRANSLATED INTO ITALIAN, EVEN IF ORIGINALLY IN ENGLISH, AND LEGALIZED BY THE ITALIAN DIPLOMATIC AUTHORITIES IN THE COUNTRY WHERE THE DOCUMENTS ARE ISSUED.
